CITIZEN'S CHARTER

THE VISION

Delhi Scheduled Castes/ Scheduled Tribes/ Other Backward Classes/ Minorities/ Handicapped Financial & Development Corporation (DSFDC) is the State Owned Corporation, incorporated under the provisions of the Companies Act, 1956 for formulation and implementation of income generating schemes for all round upliftment and development of the target group beneficiaries who are resident of Delhi. This Corporation has also been designated as State Channelizing Agency (SCA) in National Capital territory of Delhi for National Scheduled Castes Financial & Development Corporation; National Scheduled Tribes Financial & Development Corporation; National Backward Classes Financial & Development Corporation; National Safai Karamcharis Financial & Development Corporation and National Handicapped Financial & Development Corporation. Hence, the eligible persons belonging to any of the target groups can apply for financial assistance under any of the schemes being implemented by this Corporation for carrying out any permissible non-polluting income generating activity or trade.

THE MISSION

The mission of this Corporation is to provide need based loan up to a ceiling of Rs. 5,00,000=00 at a very concessional rate of interest, so that the persons belonging to any of the target groups may derive the benefit of the schemes. However, under Education Loan Scheme the upper loan limit is Rs.7,50,000=00 (if student is studying in India) and Rs. 15,00,000=00 (if student is studying abroad).

THE CLIENTS

As stated above, the eligible persons belonging to any of the target groups can apply for financial assistance under any of the schemes being implemented by this Corporation for carrying out any permissible non-polluting income generating activity or trade.

TYPES OF SCHEMES BEING IMPLEMENTED

For projects up to Rs.5,00,000=00	Any person belonging to any of the target groups residing in Dell for the last 5 years and has undergone any concerned/ relevant training from NSIC or any other recognized Institute can avail loa under this scheme. The applicant is required to submit the application complete in all respect along with stipulated documents throughout the year. The applicant must be at least 8th standard passed and must have undergone EDP training imparted by NSIC or any other equivalent institute and he/ she must have selected for loan for the same activity/ trade. However, this will not apply on traditional artisans engaged in that activity for the last past 3 years at least. In case, any applicant is not trained, he/ she will have to undergo the relevant training before applying for the loan.	
COMPOSITE LOAN SCHEME For projects up to Rs.2,00,000=00	Any person belonging to any of the target groups residing in Delhi for the last 5 years can avail loan under this scheme. The applicant is required to submit the application complete in all respect along with stipulated documents throughout the year.	
LOAN FOR PLYING COMMERCIAL VEHICLE Up to Rs.5,00,000=00	Any person belonging to any of the target groups residing in Delhi for the last 5 years and has commercial driving license and badge can avail loan under this scheme. The applicant is required to submit the application complete in all respect along with stipulated documents as and when invited through advertisement in leading newspapers.	
EDUCATION LOAN SCHEME the upper loan limit is Rs.7,50,000=00 (if student is studying in India) and Rs.15,00,000=00 (if student is studying abroad	Any student belonging to any of the target groups residing in Delhi for the last 5 years and has been admitted in any recognized University or Institute for Higher or Professional Course can avail loan under this scheme. The applicant is required to submit the application complete in all respect along with stipulated documents throughout the year.	
	Any student belonging to any of the target groups residing in Delhi for the last 5 years can be imparted training in any of the job oriented course offered by NSIC or ATDC or any other Affiliated Institute under the aegis of Government. The applicant is required to submit the application complete in all respect along with stipulated documents as and when invited through advertisement in leading newspapers.

MMITMENTS TOWARDS CITIZENS

The Corporation is committed to provide financial assistance vis-à-vis imparting training in a time bound manner as per budgetary provisions. The Corporation has fixed a time limit for processing the loan cases as one month provided there is no deficiency in the application of the documents produced by the applicant. The Corporation has also set up entrepreneur guidance cell at all the Zonal Offices. The Corporation is also committed to provide door step service as far as possible and accordingly has set up three Zonal Offices to cater to the needs of the applicants viz. **West Zone:** situated at A-33-38 B Block, Lal Building Near Police Station, Mangolpuri, Delhi catering to West District, South-West District and North-West District. East Zone: situated at D Block, First Floor, Bunkar Complex, Dy. Commissioner's Office, Nand Nagri, Delhi catering to Trans Yamuna Area i.e. East District and North-East District. **Central Zone:** situated at 2-Battery Lane, Rajpur Road, Delhi catering to Central District, New Delhi District, South District and North District.

RIGHT TO INFORMATION

The Government of NCT of Delhi introduced "Delhi Right to Information Act on 2nd October, 2001 when the citizens were given an important right to information as a matter of right from any Department/ Agency(ies) of Government of NCT of Delhi including Local Bodies and Autonomous Bodies. The Government of India too has given a parallel right to citizens through Right to Information Act, 2005 which has come into force w.e.f. 12th October, 2005. It is applicable to all public authorities of Government of NCT of Delhi including Delhi Police, Law & Order etc. This Corporation has, thus, been implementing the Right to Information Acts and has appointed The State Information Office, assistant Information Officer and First Appellate Authority.

MECHANISM AVAILABLE FOR REDRESSAL OF GRIEVANCES

The Corporation has also set up a Grievances Cell, which attends to complaints received against it. This Corporation is an independent body responsible for speedy redressal of complaints to acts of omission or of commission. It can also take up suo-motu action, where required.
