Sub: NOTICE FOR AUCTION OF CONDEMNED/SCRAPPED ITEMS


Sir,

In continuation to earlier office letter no. 3(550)/GAD/DSFDC/18-19/3645-3680 dated 22.09.2022, the auction was fixed for 10.10.2022 has been postponed due to some administrative reasons. Now, it has been approved by the Competent Authority of the Corporation that the auction will be held on 19.10.2022 at 4.00 p.m. at the same venue & place. Accordingly, as desired a fresh sealed bids will be submitted on 19.10.2022 upto 3.00 p.m.in the section of Executive Director.

The terms & conditions for auction are as under:

1. The acceptance of seal bid of auction of the condemned items will be based on "as is where is basis". The condemned items are lying at above address.
2. The condemned items can be inspected on any working day between 11.00 a.m. to 3.00 p.m. If in case, any clarification, the prospective bidders can contact to Assistant Manager (GAD), DSFDC at 1st Floor, Room No.104, Ambedkar Bhawan, Sector-16, Rohini, Delhi-89.
3. The sealed bid will have to submit the Earned Money of Rs.10,000/- through Demand Draft of "Schedule Banks" in favour of DSFDC, payable at Delhi.
4. The sealed bids will be opened on 19.10.2022 at 4.00. p.m. in the presence of all participants/intended bidders.
5. In case of any holiday falls on 19.10.2022, the auction will be held on next working day at same time & venue.
6. The sealed bid will be received/dropped in the drop box at Executive Director's section, 1st Floor, Ambedkar Bhawan, Rohini, Sector-16, Delhi-110089 during 10.30 AM to 3.00 P.M upto 19.10.2022
7. The condemned items will be sold to highest bidder only.
8. No conditional offer shall be accepted.
9. The highest bidder will have to submit proof of his/her identity (copy of Aadhar Card/Voter I. Card or any other authentic proof and PAN card) alongwith the bid and at the day of auction also.
10. The highest bidder will have to deposit 50% of the bid amount offered by him/them at the time of open bid auction through Cheque in favour of DSFDC as security. The Cheque will be returned after depositing the full amount.

11. The successful bidder will have to deposit the entire bid amount through "Demand Draft" of Schedule Banks in favour of DSFDC payable at Delhi.
12. The successful bidder will have to remove the scrapped items at his own cost within 7 days after depositing the entire bid amount, failing which the deposit will be forfeited.
13. The Earnest Money of Rs.10,000/- will be returned to the unsuccessful bidders after closing the auction.
14. Other terms & conditions shall be declared at the time of opening of bid for auction.
15. The Managing Director, DSFDC reserve the right to accept or reject the highest bid without assigning any reasons.
16. If the successful bidder(s) fails to deposit the requisite amount at any stage, the Earnest Money shall be forfeited.
