The sealed covered bids should contain rate per kg. of condemned goods alongwith the Earnest Money of Rs.10,000/- for each location in form of Demand Draft of Scheduled Bank in favour of DSFDC to be submitted in drop box at DSFDC(HQ) at address mentioned above on or before 09.09.2019 by 01.00 p.m.
3. The bids will be opened on 09.09.2019 at 04.00 p.m. in the presence of bidders, who are present.
4. The Condemned Good/Machineries etc. will be sold to be highest bidder only.
5. No conditional offer shall be accepted.
6. Highest bidder will have to submit proof of his/her identity such as copy of Aadhar Card or any authentic proof, on the day of auction.

7. The highest bidder will have to deposit 50% of the bid amount quoted by him at the time of opening of bid through cheque in favour of DSFDC as a security. The cheque will be returned after depositing the full amount.
8. The highest bidder will have to deposit remaining amount through demand draft of Scheduled Bank in favour of DSFDC.
9. The successful bidder will have to remove the items from both the locations at his/her own cost within 7 days after depositing the entire bid amount.
10. The earnest money of unsuccessful bidders will be returned on the same day after opening of bids.
11. Other terms and conditions shall be declared at the time of opening of bids.
