3. Before participating in the public auction, the participants/intended bidders will have to deposit Earned Money of Rs.10,000/- through Demand Draft of "Schedule Banks" in favour of DSFDC, payable at Delhi.
4. The Public Auction will be held on 10.10.2022 at 4.00. p.m. in the presence of all participants/intended bidders.

10. The highest bidder will have to deposit 50% of the bid amount offered by him/them at the time of open bid auction through Cheque in favour of DSFDC as security. The Cheque will be returned after depositing the full amount.
